Bylaws

- The Field Coordinator will be paid in the Fall and Spring, 1st payment when final schedule is released

BOARD MEMBER FEES WAIVED BASED ON VOLUNTEER HOURS

- Ryan made a motion that board members receive and exemption for 1 child covering the cost of registration fee pending a fee structure with additional 10 hours of volunteer work per year and 80% attendance at board meetings.
- Board unanimously voted in favor of this motion

BE UNITED ANNUAL GENERAL MEETING IN JUNE

- Leanne made a motion to change the local AGM to be in June rather than November
- Board unanimously voted in favor of this motion

Need for Volunteers – How to generate more interest

- Need incentive

- Looking at implementing a tiered fee structure to pay for Director of Coaching, Field Coordinator, coaches
- Want to find something to encourage coaches to be more invested. (Suggestions include coaches kit, additional trainings)
- Nate and BJ will work on proposed tiered fee structure
- Get feedback from Sheri and Ryan on starting place for salary for field coordinator and treasurer
- Look into the possibility of requiring one parent from each team to be serve on the board
- Adopt policy that the team manager's child doesn't pay for tournaments
- Encourage coaches to take care of managers
- Ryan proposes that managers with a child in BE United are exempt from paying tournament fees; Donna seconds; unanimously voted in favor
